1	One Spanish Schengen visa application form (fully completed, dated and signed). In case of minors (under 20 years). Both parents (and just one) must sign application form if sole custody is proved.								
2	Itinerary: Trip dates and accommodation for each day , Entries and exit from each Schengen country								
3	Confirmed return flight tickets (Round trip and International tickets) .								
4	Confirmed Hotel Accommodation (Show all applicant's name) or If staying at his/her own house/apartment, proof of ownership or rental								
5	Travel Insurance as per EU guidelines with a minimum coverage of €30,000								
6	Original employment letter (not more than 1 month) or company registration (Business owner) Original Student Certificate or Pensioner Show Proof of Pension or any other economic means.								
7	Original and copy of work permit + Re-Entry visa + Permit to stay (Must be valid before coming back to Thailand)								
8	Original Bank Certificate & Original personal bank statements for last 6 months (issue date not over 1 month and personal saving account only)								
9	Sponsorship letter + copy birth certificate + copy house registration + copy marriage certificate, copy change name certificate Original Sponsor bank statements for last 6 months along with original bank certificate (Must be mention applicant's name on paper, issue date not over 1 month and saving account only)								
10	Original Passport & 2 Copies of Passport + Copy of visas obtained in the last 5 years (Schengen, UK, US, Canada, Japan, Australia). Passport valid for at least 6 months beyond the stay in Spain with 2 blank pages								
11	2 recent color white background photographs (not more than 6 months) size 3.5 x 4.5 cm (35x45 mm) with 3 cm covering the face								
12	Proof of relationship with the main applicant/sponsor. Marriage certificate, birth certificate.								
13	Invitation signed by "Policia Nacional" in case of family or friend visits (Yellow Paper)								
14	Attested copy of the passport or the DNI or the residence card of the person living in Spain								
15	Original consent letter Traveling minors if one or both parents are not traveling with the minor
